- Amsterdam vignette for pleasure craft

Amsterdam has introduced its own unique scheme for boats both transiting and wanting to moor overnight on the city's canals. First mooted in 2021 and subject to a number of difficulties in its implementation, the system is now in operation and requires any boat on the waterways operated by Amsterdam City to have a licence, obtainable in advance.

The vignette consists of a sticker and contains a 'chip' to identify the boat. It is valid for three years from date of purchase. Note that it must be ordered online before entry to the waterways and can then be collected in Amsterdam at various places upon arrival.



Amsterdam requires pleasure craft to have a vignette when using waterways managed by the municipality of Amsterdam (the major waterways are excluded!). This is for regulatory purposes ('crowd control' on the water and for fining boats that travel too fast, make too much noise or commit other infringements). Obviously, it also brings money in the till.

Please note you do NOT need a transit vignette for reaching most marinas in Amsterdam, *het IJ*, *het Buiten-IJ*, *Noordzeekanaal* (and all major waterways used by commercial traffic connected to this, including *Zijkanaal* and *Noordhollandskanaal*), *Amsterdam-Rijnkanaal* and *Weespertrekvaart*. For details, see below. The town of Weesp has recently been 'annexed' by Amsterdam and the rules now apply also to Weesp as of 1 January 2025, but only for mooring in the town, not for passing through.

Two types of vignette

Transit vignette (*Doorvaartvignet*); this is for visitors who want to pass through Amsterdam waterways and canals. The transit vignette costs €40 and is valid for three years. More info in English: <https://www.amsterdam.nl/en/traffic-transport/boating/boating-through-amsterdam>. When you have this

type of vignette, you can purchase an additional 6 or 24 hours mooring pass (€15 for 6 hours and €30 for 24 hours), which is immediately valid but only applies to boats with a LOA of <10m and you must not overnight on your boat.

Mooring tax vignette (*binnenhavengeld vignet*, abbreviated to *BHV-vignet*). This type is essentially for **resident boat owners** who regularly want to moor their boat in the Amsterdam waterways (the canals). Maximum length over all is 10m. This vignette is mostly used for sloops that people moor near their house. Historical boats with a length over 10m can moor in the canals but need a separate authorization licence (which is not easily obtained and the number of licences is limited). Validity of the mooring tax vignette is one year. Only relevant for boat owners that regularly moor in Amsterdam; not suitable for visitors. The vignette

The vignette is a credit card type of device of approximately 5mm thick that contains a chip allowing the relevant municipality water authority (*Waternet*) to monitor the canals for boat traffic and infringements of water rules. **Note: you may never overnight on your boat, only moor, in the canals.** You can only overnight in marinas and other places with an authorised *passanten* (visitors') place. The mooring vignette or the additional mooring pass is therefor only relevant if you want to moor to go sightseeing on foot or go shopping.

The transit vignette is, for visitors, essentially only required:

- ◆ If you want to pass Amsterdam through the Standing Mast Route (SMR) on the night convoy (*Kostverlorenvaart*) route.
- ◆ If you want to pass Amsterdam through the *Nieuwe Herengracht - Amstel* route (boating area south of Amsterdam to Amsterdam v.v).
- ◆ If you want to go sightseeing with your boat or with a dinghy in the Amsterdam canals. (You need a separate vignette for boat and dinghy).

The transit vignette is not required on:

- ◆ The *Noordzeekanaal* (IJmuiden-Amsterdam v.v.) and all large waterways used by commercial barges to the North thereof (Zijkanaal, Noordhollandskanaal)
- ◆ *Het IJ* (large waterway behind the Central Station), *het Buiten-IJ* to *Oranjesluizen* (locks with access to the *IJmeer/Markermeer*) v.v. – this is the transit route *Noordzeekanaal – Amsterdam Rijnkanaal / IJmeer/Markermeer* for commercial barges and, from the sea up to Amsterdam Cruise Terminal also for sea going vessels
- ◆ The *Amsterdam-Rijnkanaal* (Amsterdam-Utrecht v.v.)
- ◆ The *Weespertrekvaart* (*Amstel-Amsterdam Rijnkanaal*).

You therefore do not need the transit vignette if you travel from Haarlem or IJmuiden (sea locks) to most Amsterdam marinas and further to the *Oranjesluizen* (locks with *IJmeer/Markermeer* access) or Utrecht (*Amsterdam-Rijnkanaal*).

Alternative routes to avoid the transit vignette

Standing Mast Route Go over the Haarlem branch of the SMR. This also avoids the night convoy through Amsterdam. Haarlem charges a transit fee also (for each transit), but you can pay this locally at the HM office and if you overnight there it is included in the overnight fee, so then there are no additional cost.

Amstelroute You can take the *Weespertrekvaart – Gaasp* route to the *Amsterdam Rijnkanaal*. This avoids transit fee areas. Note that in 2024 this route may potentially also come under the transit fee regime. This

is currently unclear.

Recommendation If you want to visit Amsterdam with your boat, go to a marina (no transit fee) and then take the metro or ferry to visit the city centre.

Not having a vignette is an offence, punishable by a fine. On the SMR the bridge operators may enforce it. On the other waterways patrols by Waternet or the police may check the vignette. Many Dutch visitors do not purchase the vignette and there are stories going around on Dutch boating forums that they are never checked. At your own risk!

Buying the vignette

The purchase of the vignette is bureaucratic and not well organized for non-Dutch speakers. You need to fill in a form in Dutch only (some translations below), pay by credit card (Mastercard and Visa only) and then the vignette is sent to you by regular mail, or you can collect it during business hours at one of the shops participating in the collection regime.

You must decide whether the vignette is sent to you by ordinary mail (please allow for sufficient time for the vignette to arrive before you leave on your trip - it will take approximately one week to arrive in the UK) or to order it while underway and collect it soon thereafter at one of the collection points.

On the delivery options screen a map should appear with the location of the various collection points. If it does not appear, check your security settings (external referrals and pop ups need to be allowed). After you have received the confirmation e-mail you presumably (I did not check this out in practice) must show the confirmation e-mail and then you will receive a vignette. See the map with collection points and their details in the annex.

Note that most (but not all) of those shops are located *within* the area where you need a transit vignette. You can, however, print the confirmation e-mail and stick it to the outside of your boat in a transparent cover en route to collect the vignette. If ordered online, you will need a printer onboard or find a friendly HM who is willing to print the confirmation e-mail.

Once obtained, you must activate the vignette. Instructions are included with the vignette. You need the vignette number and an activation code that is provided with the vignette. You need to upload a full picture of your boat. You need to place the vignette at the left aft side of your boat. Below you will find some translations of the forms that you are required to fill in to obtain the transit vignette and the addresses of the collection points. Please note that the rules and procedures may change, even during the boating season. Check the links provided above before you travel to Amsterdam by boat.

Website Amsterdam

Please note that the website on which you need to make the application is quite rudimentary. If you use a browser with enhanced security settings (pop ups and external referrals blocked) you may not be able to go from the form to the payment system. For downloading the *samenvatting* (summary) of your application, pop-ups need to be switched on.

Once successfully ordered, you will receive an e-mail in Dutch (translation provided below). In brief it also says: *'You can print the confirmation e-mail and stick it in a plastic cover on the left aft side of your boat as a temporary measure'*. If you are checked, apparently you can get through on the basis of the e-mail only. Presumably there is a time limit to this, but this is nowhere stated.

- ◆ Surf to www.amsterdam.nl/varen and click on **“Vignetten”**
- ◆ Click on the button **“Doorvaartvignet”** and thereafter on **“Vignet activeren”**
- ◆ Click on the blue button **“Doorvaartvignet activeren”**. Fill in your vignette number and activation code.
- ◆ Fill in your date
- ◆ Upload a picture of the whole of your boat, without tarpaulin. This is not obligatory, but it may be useful when your boat is missing or stolen.

You will receive a confirmation by e-mail if the activation has been successful. The vignette is valid for 3 calendar years.

Mooring

Do you wish to moor in Amsterdam? Purchase on our website **“6 uur afmeren”** (“6 hours mooring”) or **“24 uur afmeren”** (“24 hours mooring”). This is obligatory if you wish to moor in Amsterdam.

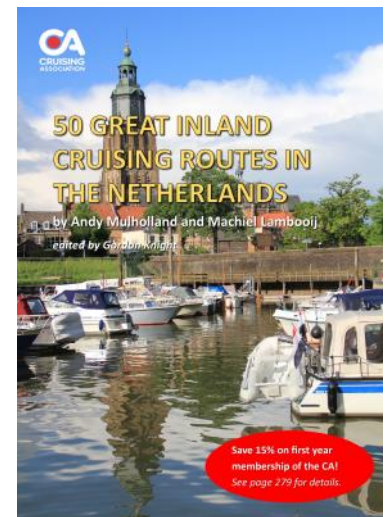
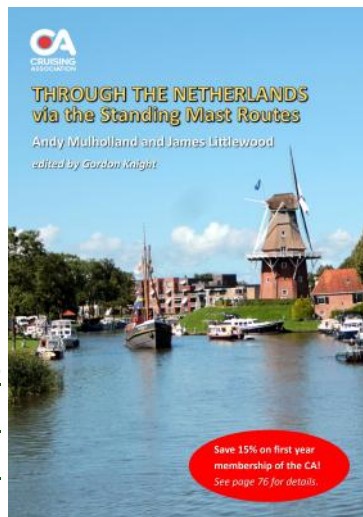
If you select 'Direct pickup' for your vignette, you will receive a list of pickup locations together with a link to an online map (see screenshot below) showing where they are. You can then choose the most convenient one and click on the map symbol for the relevant website with business opening hours and contact details.

Note: the data was correct as on 26 February 2023. Collection points may change over time.
